B/Ds should absolutely be required to disclose recruiting package details. Investors expect their advisers to act as fiduciaries (per Rand Report). Perpetuating a system that creates ongoing conflicts of interest without any disclosure is a woeful disservice to investors.

If advisers and B/Ds are not ashamed of these deals there should be no problem
